They will also:

- » Deepen their understanding of cross-sector organizational leadership practices;
- Acquire innovative skills to implement sustainable development techniques within their own organizations;
- Disseminate leadership best practices to their organizations, their colleagues and peers throughout their industries;
- » Foster increased economic opportunities and partnerships between Caribbean and Canadian leaders and organizations; and
- » Become part of a global inter-generational leaders alumni network spanning business, government, labour and civil society.
